

Oakley and Deane Parish Council

Minutes of the meeting of the Planning Committee held on 22 August 2019

Present: Mr. Hewitt (Chairman), Mr. Bealing, Mr Bullions, Dr. Johnstone and Mr. Paler, and Mrs. Taylor (Borough Councillor). Two members of the public attended the meeting.

1. Apologies

Apologies were received from Mrs. Smith

2. Minutes of the meeting held on 8 August, having been circulated to all members prior to the meeting were approved by the Committee and signed by the Chairman as a true record of the meeting.

3. Planning Applications

19/019/06/FUL Holbrook House 32 Oakley Lane. Removal of a window and replacement with a door to provide an additional entrance to offices.

Members do not feel that the plans provide sufficient detail for them to make a decision on whether they can support the application or not.

Their main concerns are:

- the proposed ramp is not shown in the drawings. What effect would the ramp have on the provision of parking spaces (it was agreed when application BDB35569 was granted that a minimum of 8 parking spaces must be maintained). One possible solution was proposed, that a temporary ramp be used when needed but was able to be removed when not in use.
- the style of the door is not clear the door to the upstairs offices is dark wood with a canopy and any new door should be similar in style
- it is not clear whether the brickwork above the window will be removed or not this would greatly affect the appearance of this aspect of this old building.

• the cellar is not shown on the drawings and the effect of the ramp on the cellar is not mentioned Requested more detailed plans (and an extension granted until after the next planning meeting on 5th Sept), or the Parish will have to object to the application.

19/02142/HSE 15 Fox Lane. Erection of single storey rear extension, alterations and new pitched roof over existing bungalow to form new bedroom. Members had no comments and no objections

19/02128/TWRN 62a Lightsfield. Fell 5 Trees. Members had no comments and no objections.

19/02261/TWRN 64a Lightsfield. Fell 1 Beech Tree. Members had no comments and no objections.

19/02043/HSE 105 Oakley Lane. Erection of detached double garage. Members had no comments and no objections

19/02134/ADV 32 Oakley Lane. Display of 1 internally illuminated logo, 3 x Non illuminated wall mounted aluminium panels, 1 x non illuminated post mounted aluminium panel, 1 x internally illuminated Totem, 1 x non-illuminated Acrylic letters. Members had no objections provided that the lighting density conforms to the Environmental Health and Highways standards.
