87/P/24 Applications

a. 24/02455/HSE | Erection of single storey rear extension with associated fenestration following demolition of existing conservatory | Hurstwood 2A Andover Road Oakley Hampshire RG23 7HB – MOP 1 advised of the logistics plan for delivering materials and gaining access to the works given the restricted access to site and the proximity of footpath 9b. The planning committee had no objections to the plans provided that the conditions mentioned by Hampshire Countryside services were adhered to in relation to materials not being stored on footpath 9b. In addition, no site material deliveries should be carried out before 09-00 due to the proximity of the pathway as a route to the local school.

b. T/00548/24/TPO | T1 - Corsican Pine: prune and remove major deadwood. T2 - Hawthorn - reduce to previous pruning | 26 Sycamore Tree Road Oakley Basingstoke Hampshire RG23 TGB – The planning committee had no objections to the proposed pruning works of the 2 trees. However, we would point out that both trees are in a TPO area and that the site is in a conservation area which is in contradiction to details provided in the application form.
