

Oakley and Deane Parish Council

Report from planning meeting held on 16th March between Mr Aylmer and Mr Bullions. Mrs Meyer (Deputy Clerk) was also present. 6 members of the public (MOP) were present.

The agenda for the 16th March was issued on Friday 10th March, but at 7.30pm the meeting was not quorate and the meeting was closed.

- 1. Mrs Hayman and Mr Rowley were unable to attend the meeting.
- 2. The report from the meeting on the 2nd March received no comments. It will be published on the Oakley & Deane Parish Council website.
- 3. Under S101 delegation (agreed on 8th September by the full Parish Council), the formal meeting was closed and an informal discussion session on applications followed. The below comments and recommendations will be sent to the Proper Officer (The Clerk) to decide and then send to Basingstoke and Deane Borough Council Case Officers:

23/00419/FUL | Erection of 1no. dwelling with car parking and landscaping | 4 Fox Lane Oakley Basingstoke Hampshire RG23 7BB

MOP1 spoke about the application. Had taken pre-application advice from the Borough on the first application for this site. This was withdrawn. The new application takes into account Neighbourhood Plan considerations and addressed other concerns.

MOP2 spoke to raise concerns over noise, pollution, privacy and safety as the new drive way and parking area is very close to their property and patio.

Councillors recommended to approve this application but with conditions attached, namely it would remain a single storey building and any future applications to build a second storey would be rejected. This would be to protect the neighbours' privacy. And secondly there is proper screening between the site and the neighbours to protect any overlooking concerns. Due to the busy nature of Fox Lane, it would be good if construction traffic could park onsite.

Five MOPs left the meeting.
